1. All reservations require a **Non-Refundable Deposit of either \$150 or \$250** depending upon the vehicle and hours being booked. The deposit shall be paid at the time that the reservation is made.
2. All vehicles owned and/or operated by Sentinel Limousine are designated as **non-smoking**.
3. All vehicles are thoroughly cleaned and checked for damage prior to each engagement. The client shall be responsible for any cleaning or repairs which may be required due to any act of negligence or disregard by the client or by the client's guests. Please note: Vomiting cleaning fee is \$250.00 and results in the immediate termination of the run.
4. Any time past the arranged drop-off time will be an additional charge in 30 minute increments.
5. An itinerary for the evening is attached.
6. Sentinel Limousine can not be held liable for items left in any vehicle. Please inspect the vehicle prior to dismissal.
7. Sentinel Limousine reserves the right to immediately terminate the job, **for all parties in attendance** for the use of illegal substances and /or any illegal activity by any guest in attendance. There will be no refund of any monies to the client, due to the negligent behavior of the passengers.
8. The DEPOSIT and ALL BALANCES are NON-REFUNDABLE
9. NO ONE UNDER 21 IS ALLOWED IN OUR VEHICLES WITH ALCOHOL EVEN IF ACCOMPANIED BY ANYONE 21 YEARS OF AGE OR OLDER
